TUITION PAYMENT PLANS

Plan One: Pay in full by August 31, 2009./ Zapłacenie całej należności do 31 sierpnia, 2009.

Plan Two: Make two payments -50% by August 31, 2009 and 50% by January 31, 2010./ Zapłacenie należności w dwóch ratach: 50% do 31 sierpnia, 2009 i pozostałe 50% do 31 stycznia 2010.

Plan Three: Pay 10% of your total tuition bill before the first of every month. 50% of your total bill must be paid by January 31, 2010. Płacenie części 10% przed pierwszym dniem każdego miesiąca. 50% całej opłaty musi zostać zapłacone do 31 stycznia 2010 r.

a) A contributing Parishioner is registered in Sacred Heart Parish, uses parish envelopes and donates at least \$500 a year/ that means at least \$7.00 regularly in all Church envelopes./ Ofiarny Parafian-Zapisany do parafii-co tydzień w kopertkach ofiaruje kwotę 7 dolarów.

b) The Pastor of all Non-Parishioners will be notified that your child(ren) is(are) attending our School. It is the policy of the Archdiocese that if you are a contributing parishioner at a parish other than Sacred Heart, you are entitled to the Parish Assessment Support from your parish for \$250. When we receive the \$250, the support money will be applied directly to your tuition bill.

c) All parents are required to sign a "terms of registration agreement" in order for your child to be registered.
